## TRANSFORMING WITH OUR SOCIAL MISSION

In the four years that Caritas Singapore has been formed, we have seen a sea of change, a transformation of the Church's charitable and social mission scene.

Once called the Church's best kept secrets, many in the Catholic community are now aware of and familiar with our Catholic Social Teaching. The Salt of the Earth study guide and its related publication, Salt & Pepper, have been instrumental in providing a much needed introduction to our social teachings. I hope that Catholics will now take up the newly-introduced Labourers of the Harvest study guide to learn how to apply these social teachings to their workplace.

The vibrancy of the social mission scene was very evident at the recent Social Mission Conference 2010 which I attended. I was impressed by the full-capacity crowd of engaged participants and the quality of the content and discussions. The theme of the conference, "Transforming ourselves and society in charity and justice" was very apt for this stage in the development of our social mission in Singapore.

With the existing 21 Catholic charitable groups and three new ones (CHARIS, CLARITY and ABLE) being established under the umbrella of Caritas Singapore, we collectively cater to a wide range of constituencies from the poor to the mentally ill. But are we doing enough for those who are in need in society?

The Church does not intend to cover all grounds, but rather work with other charities, whether secular or from other religions, to ensure that societal needs are met in the aggregate. Our focus in the Church – and this certainly has been the recommendation of Caritas Singapore Community Strategy – to focus where the needs are greatest and where Catholics and the Church can make a significant difference.

One big difference which we can make is in our Catholic ethos and approach to charitable work.

Many people think of charity as giving alms, a handout, and sometimes, a hand-up to those who are poor and downtrodden. And when we give, we feel good that we have done good, that we have been generous.

The Church's teachings on charity go further than that. She teaches that charity is driven by justice. We must give the other person what is due to him or her. Giving to the poor out of our own abundance is not generosity on our part, but simply following the commandment of Jesus to love one another as He has loved us.

Charity also demands justice. If we donate generously to those in need but do nothing to address the systems that prevent the disadvantaged from rising up in society, we have not practised Christian love. We would merely be dealing with the symptom of a societal issue but not its root cause. The problem will simply perpetuate.

The challenge then for Catholics, for Caritas Singapore, and for our many Catholic charity and community organisations, is how we reach out to our beneficiaries, not just in charity, but also in justice. To do justice will require us to question social norms, unjust treatments, and our very own attitudes towards our fellow men.

This requires transformation. Many Catholics need to be transformed in their attitudes to fully embrace the concept of charity with justice. And, certainly, society will be transformed when true justice resonates in all walks of life.

The conference theme thus also defines the next stage in the development of Caritas Singapore and the social mission journey of the Church in Singapore. I am sure that Caritas Singapore and the Catholic community in Singapore will rise to the challenge.





## **COMMUNITY STRATEGY**

As a follow up to the Community Strategy report developed in early 2009, Caritas Singapore has been working with member organisations and Catholic groups to implement the recommendations.

During the year, initiatives were focused on the enhancement of existing services provided by member organisations, the creation of new charity groups to needs not served by the Church, and programmes to educate Catholics on social issues (see box below for highlights of actions).

#### Enhancements to service programmes

#### • For low income and poor families

A joint study of the poor was commissioned by Catholic Welfare Services, Society of St Vincent de Paul and Caritas Singapore to understand the poverty landscape, to enable the implementation of new service programmes for beneficiary families.

#### • For Families

A new programme, "Parenting United", is undertaken by Family Life Society and Marine Parade Family Service Centre and two other non-Catholic charities, aimed at promoting strong marriages, tactful parenting skills, and resilient parent/ child relationships.

#### Creation of new charity groups

#### CHARIS: For Overseas Humanitarian Work

Caritas Humanitarian Aid and Relief Initiatives, Singapore (CHARIS) was launched on 20 August 2010 to be the coordinating body for overseas humanitarian aid and mission.

#### • CLARITY: For the mentally challenged

CLARITY Singapore Limited (CLARITY) is being established to help those with psychiatric illness. It will provide rehabilitation, support and essential training to their beneficiaries from low- to middle-income families.

#### • ABLE: For the physically challenged

Abilities Beyond Limitations and Expectations Limited (ABLE) is being established to help those who are physically challenged. Focus will be on training, skills development and integration of beneficiaries back into society.

#### **Public Education Programmes**

#### • Dignity of the Elderly

A joint initiative of Singapore Pastoral Institute, Family Life Society and Caritas Singapore to raise awareness on the elderly and issues such as active ageing, value of older persons, transmission of values, care-giving and end of life matters.

#### Social Response

Representatives from member organisations have formed a social response group to provide the Church's perspective on issues of social concern.

## FORMATION

Caritas Singapore seeks to promote and facilitate a greater understanding of the Catholic Social Teaching through its many formation programmes.

In line with the liturgical year, Caritas Singapore collaborated with the Singapore Pastoral Institute on the development of reflection materials for Advent 2009 (That They May Live Life to the Full!) and Lent 2010 (Walking with Christ).

In the past year, Caritas Singapore also published resource materials on Catholic Social Teaching:

- Salt of the Earth: A Group Study Guide on the Basic Principles of Catholic Social Teaching. This programme launched in 2008 has drawn more than 3,000 Catholics. In May 2010, Caritas Singapore rolled out the Tamil edition in collaboration with the Tamil Apostolate Ministry. During the year, five briefing sessions for the English and Chinese programmes were conducted for the training of facilitators. Caritas Singapore also worked together with the Church of St Ignatius, the Church of St Alphonsus and the Church of Sts Peter and Paul to introduce Salt of the Earth to their parishioners and ministries.
- Salt & Pepper: Readings on the Basic Principles of Catholic Social Teaching. This was released on Lay Apostolate Sunday in August 2009 and serves as a supplementary reader to Salt of the Earth.
- Labourers of the Harvest: A Group Study Guide on Catholic Social Teaching for Working Catholics. This study guide was launched in August 2010 for working Catholics. Three briefing sessions were held for facilitators in September this year.

In addition, Caritas Singapore worked with other groups on the conduct of formation sessions based on Catholic Social Teaching:

- Jesuit Refugee Service Singapore by Wendy Louis
- Leaders and key staff of member organisations at its Leadership Retreat by Sr Maria Lau, IJS and Christina Kheng
- Board, Committee, Caritas Singapore Parish Ambassadors and member organisations at its year-end spiritual retreat facilitated by Rev Fr Timothy Radcliffe, OP
- Member organisations and the Catholic community in a series of three talks titled "Walking the Social Talk" by Rev Fr David Garcia, OP

For the "Dignity of the Elderly" project, a series of workshops and talks were held with the aim of raising a greater awareness of the needs of the elderly and how to help them spiritually and physically.

The highlight of the year is the biennial event, The Social Mission Conference which was held on Saturday, 21 August 2010 at the St Joseph's Institution. The full-day event received an overwhelming response from the Catholic community and drew in a crowd of more than 700 in search of a clearer understanding of charity and justice in the social realm. The conference theme was "Transforming ourselves and society in charity and justice". It featured 33 overseas and local speakers and panellists including Dr Lesley-Anne Knight, Secretary General of Caritas Internationalis and Rev Monsignor David Cappo, Vicar General of the Archdiocese of Adelaide and Commissioner for the Social Inclusion Board of South Australia.



## VOLUNTEERING

Caritas Singapore promotes the spirit of volunteering and facilitates the mobilisation of volunteers in the Catholic community for its member organisations.

Its online portal helps to match potential volunteers with volunteering opportunities available at its member organisations.

In July 2010, Caritas Singapore organised its second A Big Day Out, a food and fun fair for the beneficiaries across parishes and member organisations. The event reached out to over 2,500 beneficiaries who were treated to a day of food, games, prizes and fun activities.

More than 600 volunteers from parishes and member organisations helped set up and man the 70 food and game stalls. Many volunteers also contributed their talents to organise fun activities such as face painting, balloon sculpting, fire-eating and magic acts.

This year, Caritas Singapore also coordinated two separate visits to member organisations. The first involved a visit by Alliance 21 to the Gift of Love Home where their staff hosted lunch and organised activities for the home's residents. The second involved a group of Australian netball players from the St Brendan-Shaw College to the Gift of Love Home and the Student Care Centre run by the Marine Parade Family Service Centre. This was part of the college's community work programme for its students in their trip to Singapore. They hosted lunch for the residents of the home and befriended the children at the student care centre.

### **FUNDRAISING**

Caritas Singapore seeks to raise a common pool of funds to support the work of its member organisations so that the organisations can focus on their mission of serving those in need.


Charities Week 2010 remains the major fundraising event for the year. This is undertaken on a collaborative basis between Caritas Singapore and Catholic Welfare Services during Lent across the Archdiocese and participating Catholic schools. Appeal envelopes were distributed through parishes, Catholic schools and foreign Catholic communities, together with posters.

This year, the youth of Blessed Sacrament Church organised a Youth Lenten Campaign for the Poor. In total, Charities Week raised more than \$4.6 million from parishes, Catholic schools and business enterprises.

Our Many Helping Hands programme found support from the following fundraisers:

- **Down Memory Lane IV**, a charity dinner and show organised by a group of individuals, raised gross proceeds of \$277,090 for Caritas Singapore.
- Jurong Country Club donated \$17,500 from its **33rd YHI Jurong Open Charity Golf 2009** in support of Catholic Welfare Services, a member of Caritas Singapore.
- **Sing for Charity 2010**, a Christmas project organised by a group of individuals in support of Roman Catholic Prison Ministry, Catholic AIDS Response Effort and Family Life Society raised \$71,318.
- **SICC May Day Golf Charity 2010** organised by Singapore Island Country Club donated \$20,000 to Caritas Singapore.
- **CBN Golf for Charity 2010** organised by Catholic Business Network at the Sentosa Golf Club with Minister Lim Boon Heng as guest-of-honour, raised a gross amount of \$293,988.
- Walk on Water Productions donated net proceeds of \$2,871 from their **Catholic Short Play Festival WOW 10:10** to Caritas Singapore.
- Corrinne May donated \$15,504 from her **Faithfully Yours, Corrinne May Concert** to Family Life Society, a member of Caritas Singapore.

## COMMUNICATIONS

Caritas Singapore has several communication platforms for the widespread dissemination of the social mission message, the Church's charitable happenings and the matching of charity needs and resources.

A major platform is its online portal which provides comprehensive information on the needs, work and activities of Caritas Singapore and its member organisations. A monthly online newsletter which is linked to its portal features events and happenings of Caritas Singapore.

Caritas Singapore Parish Ambassadors' programme (CPA) connects Caritas Singapore with the parishes (see page 29 for list of CPAs) where lay volunteers help spread its events and messages and facilitate its parish-related activities. A gathering of CPAs was held in February this year to update them of major events and happenings.

Each year, Caritas Singapore produces a number of publications; many of which are under its formation programme (see page 9). Caritas Singapore has a dedicated page in *The Catholic News* called "Our Social Mission" which features its member organisations, Caritas Singapore events as well as articles on Catholic Social Teaching. Many of these articles have been translated into Chinese and published in *Hai Sing Pao*. These articles are also available on its website.

A booklet, Faith, Hope and Our Catholic Charities, was published in February 2010 to share on the work of its member organisations and the programmes and services offered.

## MEMBERSHIP AND CAPACITY BUILDING

Caritas Singapore seeks to enable and build the capacity of its member organisations.

Caritas Singapore now has a total of 21 affiliate members under its umbrella (see pages 30 to 32 for the list and profile of members).

In May 2010, Caritas Singapore organised its first Leadership Retreat for Board and key executive staff of member organisations. The weekend retreat had more than 30 leaders from 16 member organisations coming together to share on the marks of a Christian leader, the social teaching of the Church and a common vision for our social ministries.

Caritas Singapore held its fourth Annual Members' Forum in June 2010 which was attended by more than 90 participants. The Review of Life methodology was introduced to help participants read the signs of the times and be Christians in the world.

In the course of the year, Caritas Singapore also organised four workshops for its member organisations with topics ranging from:

- (1) An Approach to Mental Health conducted by Denise Pang
- (2) Modern Day Slavery conducted by Sr Mary Soh, FMM
- (3) Typhoon Ketsana What's Next conducted by acts29 and Canossian Lay Missionaries
- (4) Walking the Social Talk, a four-part series talk on the Church's social teaching conducted by Rev Fr David Garcia, OP

## SHARED SERVICES AND SUPPORT

Caritas Singapore seeks to synergise resources across the many Catholic social and community organisations.

Member organisations of Caritas Singapore have been working together in cluster groups to share experiences, increase synergy and reduce overlaps. Several collaborations between organisations as well as other community groups have been undertaken during the year. These include:

- Parenting United (FLS, MPFSC)
- Study of the Poor (CWS, SSVP and Caritas Singapore)
- Dignity of the Elderly (SPI, FLS and Caritas Singapore)
- Social Response (FLS, ACMI, CMG and Caritas Singapore)

Donations-in-kind received for the year were as follows:

- 15 cartons of disposable pillow cases. These were distributed to Assisi Hospice, Gift of Love Home and Catholic AIDS Response Effort.
- 200 used story books from Catholic High School which were distributed to Canossaville Children's Home and Morning Star Community Services.
- Four personal computers and four laptops from GK Goh Holdings Limited, of which two units were channelled to CHARIS to enable its start-up; the balance were retained for Caritas Singapore's own use.

The premises of Caritas Singapore are available for member organisations to receive mail and conduct meetings in the city area. Member organisations such as the Catholic Medical Guild, Jesuit Refugee Service Singapore, Marine Parade Family Service Centre, acts29 and Faith and Light Community have made good use of these facilities. In the past year, as part of its shared services, Caritas Singapore has also provided office space for the operation of Catholic Business Network.

Start-up support was also rendered by Caritas Singapore to enable the formation of three new Catholic charities (see page 7). CHARIS has been formed and was launched by the Archbishop on 20 August 2010.

Caritas Singapore is in the process of implementing its office and accounting software. The latter will provide the platform to help its member organisations on financial accounting needs.



## **GRANT MAKING**

Funds raised by Caritas Singapore are distributed through a formal grant making process that covers early engagement, application, evaluation, approval, agreement, disbursement and monitoring.

Applications for grants from various groups were made in two window periods in January and July. These were then reviewed and vetted by a Grants Committee and approved by the Board of Caritas Singapore and the Agape Fund Trustees, for any application of Agape Funds.

#### acts29



acts29 is a youth organisation of the Catholic Church which commits itself to evangelisation through mission and dialogue. Among its work, acts29 serve the poor in the "Payatas Dumpsite" of Quezon City, Philippines.

## Archdiocesan Commission for the Pastoral Care of Migrants and Itinerant People (ACMI)

ACMI's befrienders help foreign workers in need, making hospital visits, providing food, shelter and legal aid. Its Bread Basket programme provides provisions and food to foreign workers, especially construction workers. ACMI also runs training courses to teach migrant workers basic skills.



#### Assisi Hospice

The Assisi Hospice provides integrated high quality palliative care to inpatient, home care and day care for children, adults and paediatric cancer patients as well as to other patients with palliative care needs.



#### Boys' Town Singapore

Boys' Town Singapore is dedicated to providing guidance, shelter, education, vocational training and practical living skills to youths at risk who primarily come from large, troubled, single parent and financially needy families.

#### Canossaville Children's Home

The Canossian Sisters care for young children and adolescents who are at risk, who lack parental care or family support. The home houses up to 30 children. In addition, the sisters run a Student Care Centre for children from single-parent poor families and others.



#### Caritas Humanitarian Aid and Relief Initiatives, Singapore (CHARIS)

CHARIS is the Catholic Church's umbrella body for overseas humanitarian aid. It is set up to coordinate the Archdiocesan response to disasters and humanitarian needs in fulfilment of the Church's social mission. CHARIS was launched on 20 August 2010 to take over from the Archdiocesan Crisis Coordination Team which was only focused on disaster response.



#### Catholic AIDS Response Effort (CARE)

CARE volunteers help AIDS patients and their families. The team provides befriending, counselling and support through various programmes, as well as shelter to those with nowhere to go.



#### Catholic Business Network (CBN)

CBN was set up with the mission to bring together Catholic business owners and Catholic professionals and executives for the advancement of Catholic values and ethics in their work, and to serve the broader community.



#### Catholic Lawyers Guild (CLG)

The CLG provides mutual support and encouragement among lawyers for the sanctification of their professional work, as well as the provision of legal assistance to the Church and persons in need.



#### Catholic Medical Guild (CMG)

Catholic doctors come together to examine social and ethical issues in the light of Church teachings and also conduct humanitarian missions overseas together with other organisations.

#### Catholic Nurses Guild (CNG)

This association of nurses promotes professional and spiritual growth of its members, who also participate in many Church activities to help the sick, handicapped and elderly.



#### Catholic Welfare Services (CWS)

CWS, the backbone of the Church's charity efforts since 1959, conducts a number of projects to help the poor, destitute and those in need. It runs six homes for the aged, namely:

- St Vincent Home
- Gift of Love Home
- Good Shepherd Centre

#### Christian Family and Social Movement (CFSM)



In working towards building good Christian families, CFSM assists all family members to live and fulfil their various roles in the family, work place, community and nation.



#### Faith and Light Community (FLC)

FLC reaches out to intellectually disabled people and their families to help them realise that everyone is a gift from God.



#### Family Life Society (FLS)

The Society's focus is on promoting understanding and respect for family and family life. FLS is active in pro-life, parenting and school family education, runs hotline and counselling for people in crisis. FLS has several established affiliate programmes that provide the full spectrum of support in the family life cycle:

- Beginning Experience (BE)
- Choice
- Couple Empowerment Programme (CEP)
- Couples for Christ (CFC)
- Engaged Encounter (EE)
- Marriage Encounter (ME)

#### Infant Jesus Homes and Children's Centres (IJHCC)

IJHCC welcomes children from low income families who need protection, face emotional crisis or are otherwise at risk. Its residents are engaged in social, physical and academic activities in an environment where they can be nurtured and cared for. It also runs programmes and services that include residential care, out-of-school care, learning support, community home and crisis shelter.

#### Jesuit Refugee Service (JRS) Singapore



JRS is an international Catholic organisation whose mission is to accompany, serve and advocate for refugees and forcibly displaced people. JRS Singapore works with parishes to raise awareness about the plight of refugees and supports the work of other JRS organisations in the Asia Pacific and South Asian regions.

#### Marine Parade Family Service Centre (MPFSC)



MPFSC runs a comprehensive range of social services helping individuals to realise their own potential; empower families to increase their functionality; and nurture the community to strengthen its bonds, in the East Coast area. It also runs the Cyber-Counselling for the Youth, and a Good Life at South East programme which promotes productive ageing among the elderly.

#### Morning Star Community Services (MSCS)



MSCS aims to strengthen and enrich family life through education programmes, workshops and camps for parents and children. It runs school-based social work programmes, a prison service to help inmates and their families, and various other counselling, outreach and support services.



#### **Roman Catholic Prison Ministry**

This ministry offers befriending and spiritual support services for prisoners and their families during the incarceration as well as their after-care needs. It provides counselling and fellowship services that help promote their human and spiritual development.



#### Society of St Vincent de Paul

One of the best-known Catholic charities, the Society uses monthly collections from all churches to provide direct help to the poor and under-privileged of all religions for the past 50 years. It provides monetary assistance and food rations to those in need and also befriending services.

#### Afternote:

As part of the implementation of the Community Strategy, new Catholic organisations were being established during the year to serve new areas of needs (see page 7). In the two months subsequent to the 30 September 2010 cut-off for this annual report, the following two new Catholic organisations received official charity and IPC (Institution of a Public Character) status, and were formally accepted as affiliates of Caritas Singapore:

- Abilities Beyond Limitations and Expectations (ABLE). The mission of ABLE is to enable and empower the physically
  challenged to live a productive, meaningful and independent life, and be a full contributor to the community. ABLE's first
  initiative was a collaboration with the Handicaps Welfare Association to set up a centre for the physically challenged.
- CLARITY Singapore Limited (CLARITY). CLARITY aims to provide rehabilitation, support and essential training to help people from low- to middle-income families recover from and manage their psychiatric illnesses, so that they can find sustainable and meaningful livelihood. Its planned programmes include counselling, psycho-social education, community outreach, care-giver education and support, occupational therapy and employment support.
